Future Ready Schools (FRS) is a bold effort to maximize digital learning opportunities and help school districts move quickly toward preparing students for success in college, a career, and citizenship. Beginning with a systemic planning process, FRS will help any district develop the human and technological capacity needed to personalize learning. With more than 2,000 districts already signing the *Future Ready District Pledge*, the Alliance for Excellent Education (the Alliance) and the U.S. Department of Education (ED) are leading this effort alongside a vast coalition of organizations.

Instructional Technology Best Practices

Discussion started with a review of last year's thoughts of working with the New Jersey Department of Education on a concept of "no more snow days" where educational technology could be used to make up days where school was closed due to weather or other issues. The discussion continued with identifying the topic the committee would like to focus on and if this could produce a document or white paper that would be submitted to the New Jersey Department of Education for feedback.

Discussions included a request to the committee members to encourage their staff to submit session proposals and ask their colleagues at Roundtables to solicit in their respective districts.
