Drs. Gibson and Dolan led discussions on the following agenda items:

#### **NJASA Update**

**Legal:** Maria Lepore, Chief Counsel for NJASA, provided the group with a contracts update and how to go about modifying existing contracts. It was suggested that communication at county roundtables is important and that NJASA should be contacted if there are issues with county superintendents. Board attorneys should also contact NJASA with any questions. Noted by Maria, model contracts won't work as everyone's language will be different around the state.

**Legislative:** Melanie Schulz, Director of Government Relations, reported on the salary cap sunset date and what to expect through the end of this school year. Also discussed was school funding. Flat funding is the best we can hope for as #'s are not encouraging at this point.

Bus drivers – The CDL test requires you go under the hood. 3<sup>rd</sup> party list is not yet available as of this meeting.

Chronic Absenteeism – New ESSA Law; what is the definition? Comments: Consideration needs to be taken. Everyone defines it in many different ways.
